TERMS AND CONDITIONS

When you make this booking you are entering into an agreement with us.

Please read our terms and conditions below.

PRICING

The price you will pay is for accommodation plus breakfast.

We accept the following forms of payment; cash, credit/debit card, cheque - which must be received by us no later than 14 days prior to arrival.

CANCELLATION

Once you have booked your stay, our agreement is a legal contract and any deposit paid is non-refundable.

If you need to cancel please notify us immediately.

For cancellations made up to 28 days before your booking you will not be liable for the remaining balance.

For cancellations made after this time or by failing to take up your booking without cancelling, you may be liable for the total cost of your booking.

We recommend that you take out cancellation insurance which is inexpensive and available from any good broker.

NON- AVAILABILITY

If in the unlikely event we would have to cancel your booking for reasons beyond our control, we will attempt to offer you alternative accommodation.

However, if this was not possible or is unacceptable to you, then we would refund all monies paid by you.

Our liability would not extend beyond the refund.

ARRIVAL

Your accommodation is available for you to check in from 3 pm on the day of arrival unless otherwise agreed by us. Please let us know if you intend to arrive after 7 pm.

DEPARTURE

Please be ready to leave your accommodation by 10 am on the day of departure unless otherwise arranged.
